This declaration applies strictly to all packaging materials supplied by Mainline Mouldings Ltd in the product transport system identified below:

- **Description:** Product shipping system consisting of a brown or white single-wall corrugated box branded 'Mainline' or unbranded, sealed with self adhesive packaging tape and sometimes secured with Mainline self adhesive tape.

Compliance with Essential Requirements

- Article 5 (Heavy Metals): Total concentration levels of lead, cadmium, mercury, and hexavalent chromium do not exceed 100 mg/kg across all components (box, tape, adhesive, and ink).
- Article 6 (Substances of Concern): Packaging is PFAS-free - n/a as non food packaging.
- Article 7 (Recyclability): Designed for recycling / recycled content - see above.
- Article 9 (Packaging Minimisation): Empty space has been minimised relative to the product volume, fulfilling the maximum 50% empty space ratio requirement.

In compliance with PPWR enforcement guidelines, these technical records will be retained for a minimum period of **ten (10) years** and will be made available to EU national market surveillance authorities upon legitimate request.
